5.0 ACTION ITEMS

5.1 Public Safety Areas and NASF Guidelines from DIRDC – ongoing item

On the 9th November, the State Transport and Infrastructure Council Ministers endorsed the revised NASAG guideline for Public Safety Areas which will come into effect. The implementation of the guideline will be up to each State and Territory. The Commonwealth expect further consultation with communities and are available to support jurisdictions to assist with the implementation stage.

5.2 The Commonwealth Department - Sun-Setting Regulations

The Commonwealth Attorney General recently agreed to align the sun-setting dates for a number of regulatory instruments which fall under the Airports Act. The due date for the sun-setting regulations is the 1st April 2024. This provides the Department an opportunity to review all instruments holistically and undertake a thorough consultation process.

5.3 Update on Park and Ride - DPTI

The Park 'n' Ride is now open to the public. There are some minor works still to be completed which will be undertaken over the next month.

6.0 AIRPORT UPDATE

- **6.1 Parafield Airport Limited (PAL) Report –** The report was tabled and taken as read.
- **6.2 Property and Development and Land Use Report –** The report was tabled and taken as read with the following items noted: The Property team are in discussions regarding the Masters store and hopefully some developments will be seen over the next few months.
- **6.3 Environment Report –** The report was tabled and taken as read.
- **6.4** Planning Co-ordination Forum (PCF) Report The report was tabled and taken as read.
- **6.5 Technical Working Group (PATWG) –** The working group considered a number of items raised from residents, the Airport and ASA. The item raised from residents regarded the increase in flight movements. The movements relate to training hours increasing at this time of the year because of the loss of hours during winter. Also, a wind change which increased the use of the cross runway which resulted in a lot more flight traffic in areas which traditionally don't have much traffic. The queries and questions from residents will be responded too.

The group also discussed on-airport operations relating to helicopters which the Airport and ASA are following up.

7.0 COMMUNITY AND AIRPORT AGENCY UPDATE

7.1 Federal Department of Infrastructure, Regional Development and Cities (DIRDC) Report –

Since the last meeting, a number of changes have occurred across the Australian Government ministries including a new Prime Minister, but the responsibilities of the Deputy Prime Minister who is responsible for Infrastructure has not changed.

Some recent changes which have come into effect relating to the Airports Act include a change in the Master Plan cycle with Parafield Airport moving from a 5-year cycle to an 8-year cycle.

7.2 State Department of Planning, Transport and Infrastructure Report – North–South Corridor: Both the South Australian and Australian Governments have indicated clear commitments to progress a non-stop North-South Corridor for Adelaide. Construction is currently underway on the Northern Connector, Torrens Road to River Torrens and Darlington sections of the corridor, with funding committed towards the delivery of the Regency Road to Pym Street section of South Road. Completion of these projects by 2022 will create a 47 kilometre continuous section of the North-South Corridor between Gawler and the River Torrens.

On 7 May 2018 the Australian Government announced its \$1.211 billion contribution towards the North-South Corridor. The Australian and South Australian governments are working together to identify the next priority section of the corridor and are also exploring opportunities to accelerate the funding and delivery of the project.

On 15 October the Minister for Transport, Infrastructure and Local Government, the Hon. Stephan Knoll, announced that a contract had been awarded for the business case development of the River Torrens to Tonsley Boulevard section of the North-South Corridor and the investigation into the viability of tunnels.


Once the next priority section has been identified and concept plans developed, the department will have greater certainty of impacts and will be able to provide reliable advice to affected land owners, local and state government agencies and the community. 7.3 Airservices Australia (ASA) Report – The following was noted: In quarter 3, 55,000 total movements were recorded. Helicopter movement's reduced slightly and 17 complainants lodged complaints compared to 35 in quarter 2. All complainants were concerned with fixed wing circuit training, one also mentioned airwork traffic.

It was noted that the movement numbers from 2017, in the same quarter, were 34,992 (compared to 55,000 movements). This can be explained by the intake of students and a full cadet program. It was noted some complaints were received from Mawson Lakes regarding different sounding aircraft. It was noted the Uni courses use Tobago aircraft but once these aircraft run out of hours they will be using newer aircraft.

The below graph shows the distribution of movements between a weekday to weekend, seasonally compared.

- **7.4** Aircraft Noise Ombudsman Report Nothing to report to Committee.
- **7.5 Flight Training Adelaide (FTA) Uni SA Aviation Academy Report –** The following was noted: FTA have no intention to grow further at Parafield and are a "300-student" school. The circuit at Parafield Airport has a number of constraints and operators at the airport can only fly what is allowed and safe under those constraints.
- **7.6 City of Salisbury –** The following was noted: A Water Harvesting Scheme update 2018/19 (as at 30 October 2018) was provided. 82ML of recycled stormwater has been provided from the Parafield ASR scheme to community and commercial customers across Salisbury so far this financial year. In the period 1 July 2018 to 30 October 2018, Salisbury Water has treated and injected 213ML at Parafield Airport. Repairs to the netting over all three basins is underway.

8.0 OTHER / NEW BUISNESS -

Due to recent elections, the Chair will write to the local councils to encourage Councils to nominate representatives to join the Committee.

9.0 PRESENTATIONS

9.1 PFAS Update

PFAS is a man-made chemical and is used in lots of day to day items including in food products, scotch guarding, Teflon cooking etc but was used on the airport in firefighting foam. This type of firefighting foam was used in the past by ASA, the Defence and MFS. PFAS firefighting foam was last used 20 years ago and the substance was detected as potentially unsafe 10 years ago. The main issue with PFAS is it bio accumulates overtime. It was noted that firefighting foam without PFAS is currently being used.

The Airport and relevant stakeholders have been testing for some time including drilling bores (last test conducted in September) with 3 areas of interest. The areas where PFAS has been detect is in the upper level groundwater aquifer, in very salty water. The testing sites include sampling bore water and is completely separate to drinking water. More testing will be conducted and will be drilling into council lands.

No registered wells have been detected off airport but residents close to the airport will be contacted to see if any unregistered bores are being used. GHD will work on behalf of the airport to doorknock local residents and explain the environmental testing and ask if they have a ground water bore on their property, and if yes, more discussions will be undertaken. The potential risk is considered low to the public.

Some historical investigations have been undertaken to confirm the quantities of foam used but a final estimate is hard to provide due to the multiple training runs over numerous years.

It was noted that soil testing is possible when construction is carried out on Airport, if any PFAS concentration levels are detected then the soil is kept onsite or disposed of using the proper permits. PFAS in the soil is really only concerning if soil is consumed. The PFAS levels detected so far are relativity low.

The City of Salisbury has had PFAS on their risk register since 2013. Once the guidelines were lowered, no readings have been detected over the drinking water guideline.

The research PAL has conducted is fully transparent and shared with the State EPA and the Commonwealth who is PAL's regulator who endorse the next steps. PAL is also a part of a PFAS Working Group.
